Treasurer's Report/Finance: Signature cards with current officers updated at bank (BofA). Ending BofA account balance \$638.90. Should be low point for the year. Should get ad revenue in subsequent months. No anticipated expenditures until next August. Now sharing PO Box with Kental planning group (KTPG). Gave them a key to PO Box. Budget Analyst Barbara Jordon to research whether TMAD funds can pay for PO Box. (Box rental is currently \$200/yr. So, TMAD's share in now \$100/yr.)

City of San Diego Representative's Report:

Elvis Martinez Parks & Rec: No update on lighting situation per Royal's inquiry. No street light inspection this past week since Elvis was sick with the flu. Will inspect them shortly. Aztec Landscaping de-weeded and cleared debris from the alleys. Aztec will schedule sweeper service for the alleys. Ten new rose bushes planned for Traffic Circle (SW corner).

Action Item #1: FY 24 Budget

Budget Analyst Jordon reviewed budget transfer rules. Budget transfers in similar accounts (e.g. 512XXX) may be done to cover overages or potential overages. Otherwise funds must come from fund balance to cover overages or potential overages. Transfers amongst non-similar accounts (e.g. Supplies 511XXX to Misc/Tech Services 512XXX) are not permitted. Unanticipated/Unbudgeted overages may be covered by Unallocated Reserves. In other words, Unallocated Reserves may act as a contingency fund/financial cushion. Note: Although Unallocated Reserves is GL account 512132, budget transfer may be made from it to any other expense line item like 51XXXX (Supplies 511XXX, Utilities 514XXX, Other 516XXX).

Helmich moved the following FY24 Budget. Lindahl seconded motion. Unanimous approval (McGann absent for vote).
