## Updates on Lighting Project and Historic Gate Restoration



### Talmadge Street Lights

The Talmadge street lighting project is the second of three Capital Improvement Projects specifically outlined in the TMAD Master Plan. This lighting project has remedied both Zone 1 (east) and Zone 2 (west) street lighting deficiencies in the neighborhood (excluding the street lights in

Undergrounding Project 3HH located primarily behind Hoover High School – scheduled to break ground on April 15, 2013). TMAD has installed 224 new candlestick lights throughout the neighborhood in what has been a long and complex project. This was first expected to be a 20+ year, multi-million dollar undertaking but after 10 years to reserve the needed capital, the construction phase has taken less than 14 months to complete and is projected to cost Talmadge approximately \$950,000.

The next phase is the restoration of the existing grey candlestick street lights and will consist of removing the lead paint, repainting them black, replacing the access panel at the base, and ensuring the structural integrity of the base and pole. This will likely begin in the 4th quarter and cost approximately \$170,000, which has already been reserved.

### Talmadge Historic Gates

The Talmadge gates and existing grey candlestick street lights are defining features of our community, and are part of what makes us special. Lack of maintenance over the years has led to their deterioration. In addition, several gates have been altered from their original style and one gate was removed after being hit by a car. TMAD's goal is to restore the gates to their original form and replace those which are documented as missing. The restoration and rehabilitation of the Talmadge gates is the third Capital Improvement Project outlined in the TMAD Master Plan. The projected cost of the gate restoration and replacement is approximately \$338,000 and will take roughly 18 months to complete.



The restoration of the gates is a meticulous process that will include the following tasks: inspect for structural integrity, replace deteriorated elements, upgrade the electrical components, galvanize, paint, install new fixtures, prepare original site with new footing, and install rehabilitated gate. This will be done offsite after each gate has been saw cut from its location. Once restoration is completed, the gates and candlestick street lights will be maintained by TMAD on a regular basis so as to avoid this level of disrepair in the future.

### 2013 TMAD Meetings and Elections

The TMAD Board meets monthly on the 4th Tuesday of each month (except in August and December, which are dark months). TMAD is a community organization that relies on Talmadge resident volunteers. Seven board positions will be up for election this fall at the October 22nd meeting; please consider supporting the neighborhood by serving on the Board. Keep in mind that you must attend two meetings prior to the October meeting to be eligible to run for a board position, so join us and get involved!

## Annual TMAD Assessments



As we near completion of the lighting project, the largest neighborhood improvement project that TMAD has undertaken to date, considerations are being weighed for future projects and improvements to our neighborhood.

At the January Budget meeting, the TMAD Board of Directors elected to set the fiscal year 2014 annual assessment at \$98. This fee, included on your property tax bill, builds reserves for large capital improvement projects such as the traffic circle, lighting project and historic gate restoration. The funds also provide for everyday neighborhood upkeep including:

- weekly maintenance, watering and landscaping of the traffic circle
- cut-outs in concrete parkways for tree installation
- alley sweeping and weed removal,
- ongoing care of the Talmadge gates
- a portion of the electric bill for neighborhood lighting (which has increased in part due to the addition of new street lights)

In addition to ongoing maintenance, our accumulated assessment monies were enough to contribute close to half the cost of the refurbishment, replacement and installation street lights throughout our neighborhood and reserve the money necessary to complete the project in West Talmadge. Additional assessment monies will be used to restore our historic gates and open a new Capital Improvement Project Account to address the need for sidewalk repairs.

This modest annual increase (\$10 per single family home), is the first adjustment since 2008, and with just over 1600 homes within the assessment district boundaries, will allow us to keep pace with cost increases and invest more in annual maintenance and improvements.

## Free Street Trees Available

Free street trees are available to Talmadge residents as part of the utility undergrounding program. The City of San Diego will provide and plant free trees for property owners who are willing to water and care for the trees. The current tree choices are: Crape Myrtle, Hong Kong Orchid, African Sumac, Bradford Pear, Gold Medallion, Chinese Flame, Chinese Pistache, and Jacaranda.

Trees will be planted within the public right of way in front of properties. In the event cement has been placed in this area, TMAD may pay for a cut-out, as the City does not provide this service.
